### Notes on the form overleaf

#### Gift Aid

Because it is part of a registered charity the church can reclaim standard-rate tax paid by individual UK tax-payers in respect of gift-aided donations. This increases each net gift-aided donation by 25% at no cost to the donor. (And there can in fact be a benefit to donors who pay higher-rate tax - more details from the PCC treasurer on request.)

So if you pay income tax or capital gains tax then please consider completing the gift aid declaration on the form.

Even if money is donated from a joint bank account the gift aid declaration must relate to one individual UK tax-payer. (If both parties to a bank account pay tax and wish to gift-aid separately then two separate gift aid declarations are needed.)
